Fall is a busy time, and October is a particularly eventful month with school, community and sports activities in full swing. It's also when all cooperatives celebrate National Co-op Month.



## Safety




Osceola Electric Cooperative follows safety programs to ensure the well-being of our employees, our members, and the communities we serve.

## Manager's Report

### **Fall Construction**

Highline Construction crews from Paynesville, MN have been working in the county for a couple months and have made good progress. We hope for another couple of months of construction before ground conditions change.

Osceola Electric crews are working with Highline Construction to prepare for the new three -phase line (cutting over ser-

vices), Following the completion of the new FEMA funded line.

In October Loosbrock Digging will begin plowing threephase lines. If old man winter holds off, we are planning on eight-and-a-half miles. All these miles will be replacing overhead lines that are more than 50 years old.


Three-and-a-half miles will be on Silver Avenue from 180th Street to A34. Four-and-a-half miles will start on Warbler Avenue and 200th Street and finish up south of May City. The final mile-and-a-half will tie our Allison substation to Business Corner. This new feeder will give OEC multiple connection points for back feeding if needed, for maintenance, outages, or storm issues.

OEC has taken advantage of two programs FEMA offers, Public Assistance (following storms) and Mitigation Funding. These funds have allowed us to retire dozens of miles of 1950 to 1960 vintage three-phase overhead lines and convert them to underground. In doing so we have rebuilt the backbone of our system and increased reliability. **42395** 

OEC crews have rebuilt more than 50 miles of both single and three-phase overhead lines using our new construction spec's—large poles, shorter spans, and aluminum conductor since 2015.

## Energy Efficiency Tip of the Month

Did you know using your dishwasher is more energy efficient than washing a load of dishes by hand? To maximize efficiency, wash full loads in the dishwasher and don't block the arms or other parts that move while the appliance is in use.

For additional savings, turn on the "air dry" setting instead of using the "heat dry" setting and use a rinse aid to help dishes dry faster without spotting and streaking.

# 2023-2024 Iowa Home Energy Assistance Program

The 2023-2024 Low-Income Home Energy Assistance Program (LIHEAP) has been established to help qualifying low-income lowa homeowners and renters pay for a portion of their primary heating costs for the winter heating season.

The assistance is based on household income, household size, type of fuel, and type of housing.

### How to Apply for LIHEAP

### WHEN TO APPLY

- Elderly (60 & over) and/or disabled October 1, 2023 to April 30, 2024
- All other households November 1, 2023 to April 30, 2024

### WHAT TO TAKE

- Proof of Income (for all household members age 18 and over) Depending upon your household income type, income documentation from the past 30 days, the last 12 months, or last calendar year, whichever is easier or more beneficial for you.
- Proof of Social Security Numbers for all household members (documentation required)
- Most recent heat bill
- Most recent electric bill

### **WAGE EARNERS**

Please bring copies of your check stubs for the 30-day period preceding the date of application, or a copy of your most recent federal income tax return.

### **FIXED INCOME**

This income may include: Social Security Benefits, Supplemental Security Income, Veteran's Assistance, Unemployment Insurance, and pensions. Please bring copies of your check stubs from the previous 30 days.

### SELF-EMPLOYED/FARMERS

Please bring a copy of your most recent federal income tax return.

If you receive alimony or child support, it will also need to be verified. Additional income not listed here may be required.
