ELECTRIC RATE & LOAD CONTROL AGREEMENT FOR SPACE
HEATING

This agreement made and executed by and between Osceola Electric Cooperative, Inc. headquartered in Sibley, Iowa, hereinafter referred to as the "Cooperative", and _____, hereinafter referred to as the "Member.

WHEREAS, it is in the joint interest and benefit of the named parties to meter and/or control the use of electrical energy delivered by the Cooperative to the Member through the installation of a meter and/or load management control device:

NOW THEREFORE, in consideration of the mutual benefit to the parties thereto, it is hereby agreed by and between the parties as follows:

1. At the account location described by the number above, the member, at his expense, shall supply and install space heating with motor loads approved by the Cooperative
2. The member shall supply and install all wiring necessary to provide the point for installation of the meter and/or load management control device in accordance with the standards adopted by the Cooperative.
3. The Cooperative, at its expense, shall supply the meter and/or load management control device, both the meter and load management control device shall be and remain the property of the Cooperative. Permission is hereby granted the Cooperative, its agents and employees to enter upon the member's premises for the purpose of

installing, maintaining, reading, relocating, repairing, inspection of, and removing said load management control device, meter and appurtenances thereto.

4. The member shall, at his own expense, maintain the space heating system and shall periodically inspect the premises being serviced by the system to ascertain the proper function of the said system and shall immediately notify the Cooperative of any malfunctions of the meter and/or load management control device.
5. Member has one of two options listed below to obtain space heating rebates as per policy 3-2A.
 - a) Space heating having load management control device and sub-meter installed.
 - i. Usage subject to rate schedule H as described on Summary of Rates. Until Cooperative's energy provider removes incentive for electric space heating then load management control device will operate as needed.
 - b) Member opts not to install sub-meter, but installs load management control device.
 - i. Space heating unit will have load management control device controlling load as needed. Member will be billed on existing rate as described on Summary of Rates.
6. The member hereby represents and warrants that he is the owner of the premises upon which the meter and/or load control equipment is, or will be, installed or, that the owner of the premises is hereby identified below and has consented to such installation.
7. The member shall not tamper with, alter, or modify the meter and/or load management control device and appurtenant equipment so as to circumvent its operation, nor shall the member install or add and electrical powered devices to consume electricity through the heating system without first obtaining the express written consent of the Cooperative.
8. Any breach of the provisions of this Agreement will be cause for the Cooperative, at its option, to cancel this agreement and remove its equipment from the member's premises, without further notice to the member or the owner of the premises.

9. This agreement shall be in effect as of the date of the Certification of Agreement as stated below.
